Policy 6186

Education for Minors on Confinement Status

The Solano County Office of Education (SCOE) recognizes the need to provide an appropriate alternative educational program to minors who are on confinement status while in the Juvenile Detention Facility (JDF). SCOE shall provide these students with comparable school work necessary to meet the challenging academic standards afforded to other students in the JDF.

Teacher Protocol

The protocol for teachers providing school work for minors on confinement status at the JDF shall be as follows:

- 1. Teachers will be notified by probation counselors regarding which minors are on confinement status.
- 2. Teachers will provide work to the minors based on Individual Learning Plans (ILPs).
- 3. Teachers will maintain a log of all work provided to minors on confinement status.
- 4. Teachers will document which minors agree to or refuse to complete the assigned work while on confinement status.
- 5. Teachers will document all work completed by minors on confinement status.
- 6. Teachers will keep a student file with all work completed by minors who are on confinement status.
- 7. Probation counselors will be notified by the teacher regarding which students are failing to complete assigned work.
