

**TERMS OF OFFICE**

- I. Membership: The Solano County Board of Education shall consist of seven members. (Education Code section 1000)
- II. Eligibility: Any registered voter is eligible to be a member of the County Board of Education except the County Superintendent of Schools, any member of their staff, or any employee of a Solano County school district or charter school. (E.C. § 1006)
- III. Elections: Members of the County Board of Education shall be elected on the date and in the manner prescribed for the election of members of governing boards of school districts throughout the county provided such elections are held throughout the county on the same date; otherwise the election shall be consolidated with the direct primary election. Members elected at the time of the direct primary shall take office on the first day of July, and members elected at the date on which members of the school district governing boards are elected shall take office on the second Friday in December subsequent to their election and shall serve a term of four (4) years. (E.C. § 1007)

The election of the County Board of Education members shall be held on the first Tuesday after the first Monday in November in even-numbered years to fill the offices of those members whose terms expire on the second Friday in December next succeeding the election. (E.C. § 1007)

Before entering upon the duties of their office, the board member shall take and subscribe to the oath of affirmation set forth in the Constitution of California. (E.C. § 1360)

A member whose term has expired shall continue to discharge the duties of the office until their successor has qualified by taking the oath of office. (Government Code sections 1302, 1360; E.C. § 5017)

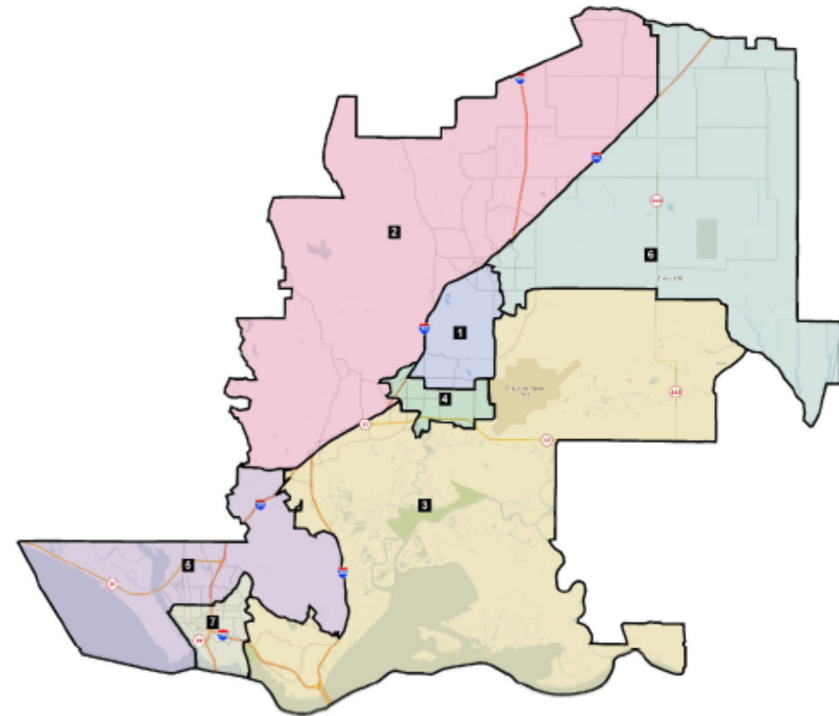
- IV. Trustee Areas: Each member of the Solano County Board of Education shall be an elector of the trustee area which they represent and shall be elected by the electors of the trustee area. (E.C. § 1000)

The trustee areas shall consist of territories of approximate equal population. Their exact boundaries shall appear as Appendix A of these policies.

**Trustee Area 1**

Beginning at the intersection of Elmira Rd. and I-80 (eastern-northbound lanes), proceed in a southwest direction along I-80 to the Air Base Parkway.  
 Continue eastward along Air Base Parkway to the North Texas St.  
 Continue southward along N. Texas St. to E. Tabor Ave.  
 Continue eastward along E. Tabor Ave. to Walters Rd.  
 Continue northward along Walters Rd. to Air Base Parkway.  
 Continue eastward along Air Base Parkway to Peabody Rd.  
 Continue northward along Peabody Rd. approximately 15,700 feet (3 miles) to the Vacaville city boundary. This boundary extends due west from the Putah South canal (E-W direction) to the east of Peabody Rd.  
 Continue eastward along the Vacaville city boundary to the Putah South canal in a general N-S direction.  
 Continue northeastward along the western edge of the canal to Foxboro Parkway.  
 Continue northwestward along Foxboro Parkway to Youngsdale Dr.  
 Continue northeastward along Youngsdale Dr. to the Putah South canal approximately 160 ft. past Marna Dr.  
 Continue northwestward then northward along the western edge of the canal to Alamo Dr.  
 Continue westward along Alamo Dr. to Tulare Dr.  
 Continue northward along Tulare Dr. to Marshall Rd.  
 Continue eastward along Marshall Rd. to Berryessa Dr.  
 Continue northward, then westward along Berryessa Dr. to Shasta Dr.  
 Continue northward along Shasta Dr. to Elmira Rd.  
 Continue westward along Elmira Rd. to I-80, the point of beginning.

**Trustee Area 2**

Beginning at the intersection of Elmira Rd. and I-80 (eastern-northbound lanes), proceed in a southwest direction along I-80 approximately 6.4 miles (33,800 ft.) to the Putah South canal.  
Continue westward, then southwest along the northern bank of the canal to the bridge at Capitola Way.  
Continue southward along Capitola Way, it turns southwestward and becomes Woodcreek Dr.; continue to Oliver Rd.  
Continue southeastward along Oliver Rd. to Travis Blvd.  
Continue eastward along Travis Blvd to 2nd St.  
Continue southeastward along 2nd St. to the Fairfield Linear Park.  
Continue southwestward along the Fairfield Linear Park to I-80.  
Continue southward along I-80 (eastern-northbound lanes) approximately 360 ft. to Rockville Rd. overpass, then continue southward along I-80 (western-southbound lanes) to the Hwy 12 W off-ramp.  
Continue westward along Hwy 12 (Jameson Canyon Rd.) to the Solano County boundary.  
Continue northward along the Solano County boundary (according to the description, as follows, of the Fairfield-Suisun Unified School District boundary, which includes part of Napa County) "to a point on the Napa – Solano County boundary that bears North 32°11'10" East 597.81 feet from Station Number SN-21 as shown on the Record of Survey, filed in Book 17 of Surveys, Page 17, Solano County Records; said point is also located in Section 28, Township 4 North, Range 3 West, M.D.B. & M.; thence from said point of beginning, northerly and easterly along said county boundary to the south quarter corner of Section 35, Township 6 North, Range 3 West, M.D.B. & M.; thence north to the north quarter corner of said Section 35; thence east along the south line of said Section 26 to a point which bears West 771.13 feet from the southeast corner of said Section 26; thence North 1725.93 feet; thence East 123.88 feet; thence North 708.57 feet; thence West 3196.80 feet; thence North 2128.93 feet, more or less, to the south line of Parcel 2 as it is shown in Book 17 of Parcel Maps, Page 1, Map No. 4250, Napa County Records; thence along the southerly boundary of Parcels 2 and 1, as shown on said Map No. 4250, North 82°26' East 1510.98 feet and South 66° 45' East 74 feet, more or less, to the intersection of the southerly line of Parcel 1 and centerline of Section 26; thence North along the centerline of said Section 26 and Section 23 to the center of Section 23 of said township; thence west along the south boundary of the Chimiles Rancho to the west boundary of the lands of J. W. Reans; thence northerly along the west boundary of the land of said Reams and the west boundary of the Coombs and Coghlan tract of land to the north boundary of Township 6 North, Range 3 West, M.D.B. & M.; thence East along said township boundary and the north boundary of Township 6 North, Range 2 West, M.D.B. & M. to the west boundary of Solano County."

Continue southwest along I-80 (western-southbound lanes) to the Mason Rd. - Elmira Rd. overpass; proceed to the eastern-northbound lanes, the point of beginning.

**Trustee Area 3**

Beginning at the intersection of the Fairfield Linear Park and 2nd St., proceed in a southeasterly direction along 2nd St. to W. Texas St.

Continue eastward along W. Texas St. to the easternmost mid-point of the street's curve northward into N. Texas St.

From that mid-point, continue in a southeast direction approximately 150 feet to a railroad track.

Continue southwestward along the railroad track to Cordelia St. This coincides with the Suisun City boundary.

Continue in an easterly direction along the Suisun City boundary to Peterson Rd.

Continue eastward along Peterson Rd. (it becomes Scandia Rd.) to the Fairfield city boundary line adjacent to Travis Air Force Base.

Continue northward along the Fairfield city boundary to Air Base Parkway.

Continue eastward along Air Base Parkway to Peabody Rd.

Continue northward along Peabody Rd. approximately 15,700 feet (3 miles) to the Vacaville city boundary. This boundary extends due west from the Putah South canal (E-W direction) to the east of Peabody Rd.

Continue eastward along the Vacaville city boundary to the Putah South canal in a general N-S direction.

Continue northeastward along the western edge of the canal to Foxboro Parkway.

Continue southeastward along Foxboro Parkway to Nut Tree Rd.

Continue northward along Nut Tree Rd. to Cogburn Ave.

Continue eastward along Cogburn Ave. to Newcastle Dr.

Continue southeastward along Newcastle Dr. to Vanden Rd.

Continue northward along Vanden Rd to Alamo Dr.

Continue eastward along Alamo Dr. (it changes name to Fry Rd. after crossing Leisure Town Rd.) to State Rte. 113 (Rio Dixon Rd.).

Continue southward along State Rte. 113 to Maine Prairie Rd.

Continue eastward along Maine Prairie Rd. to Norton Rd.

Continue northward along Norton Rd. approximately 140 ft. to Hoss Slough.

Continue southeastward along Hoss Slough to the junction of Cache Slough and Maine Prairie Slough (according to the description, as follows, of the Dixon Unified School District boundary), "thence up (westerly) the Maine Prairie Slough to Hastings Cut; thence Southwesterly along said Cut to Linda Slough; thence down Linda Slough about 1/8 mile to Eastern section line of Section 20, Township 5 North, Range 2 East; thence South about ¼ mile to the Southeast corner of said Section 20."
