Juanita provided a copy of the legislative tracker document to the Chair and the Vice chair and presented the following bills that are moving through the legislative process. AB 1947: staff contracting days-is on its way to Senate for vote. AB 2268:TK English language Proficiency Assessment exemption- passed out of the Assembly and is on its way to the Senate committee. AB 2206: child daycare facilities to have fire clearance requirements- has been amended. AB1925: childcare and development programs eligibility requirements- did not pass. AB-1930: teacher credentialing requirements- moving forward to the Senate Committee. AB-2226: elementary education, a child must complete a year of kindergarten before entering the first grade-did not pass. AB-2476: childcare services for alternative payment programs- has been ordered for a third reading. AB-2381: California state preschool program reimbursement rates- has been ordered for a third reading. Juanita presented the Zip Code Priorities report for signature. Susan Smith signed the report with no changes. The report will be presented at the General Meeting on June 20, 2024. Juanita presented an update on the Blooming Solano pilot program. The goal was to enroll 20 providers, there are 17 providers currently enrolled. The program support specialist is supporting providers through one-on-one training and transition support as the pilot program will end on June 30, 2024. The data that was collected by WestEd and given to First 5 California indicated that 35 teachers utilized the system and |
